Statement on modern slavery

Background

This is Corona Energy Limited's ("**Corona Energy**") statement on slavery and human trafficking on behalf of the Group following the introduction of the Modern Slavery Act 2015 ("**MSA**"). This statement is made pursuant to section 54(1) of the MSA.

Corona Energy fully supports the aims of the MSA and is committed to eliminating all forms of slavery and human trafficking wherever possible.

Our business and supply chain

Corona Energy is an electricity and gas supplier for non-domestic premises which specialises in supplying gas to large multi-sites and also offers other energy services such as the provision of automated meter reading (AMR). Our policy on slavery and human trafficking

Corona Energy does not tolerate slavery and human trafficking in any form in any parts of our business or our supply chain. Corona Energy is committed to acting ethically and responsibly in all business relationships and to endeavour to ensure that slavery and human trafficking are not present in any part of our business or supply chain.

Our processes to prevent slavery and human trafficking

In the financial year ending 31 March 2017, Corona Energy undertook the following reviews in order to try to ensure that slavery and human trafficking was not taking place in our business or supply chains:

- We conducted a review of the various parts of our business. The result was that we identified no slavery or human trafficking taking place within any parts of our business.
- We conducted a review of our existing processes in place to ensure that slavery or human trafficking was not taking place within our supply chains.




As a result of the supply chain review, Corona Energy has now implemented appropriate measures in our supplier onboarding process to try to ensure that no slavery or human trafficking enters our supply chain. In addition, Corona Energy intends to:

- ensure we maintain appropriate steps in our procurement procedures in order to try to prevent any form of slavery or human trafficking entering our supply chain;
- continue to monitor and assess categories of third parties we identify as most at risk in relation to slavery and human trafficking; and
- where appropriate provide training to relevant Corona Energy employees to ensure a high level of understanding of the risks of slavery and human trafficking.

Our ongoing commitment to preventing slavery and human trafficking

Corona Energy will continue to review our processes in relation to the prevention of slavery and human trafficking in our business and supply chain.
